Meeple Treks Terms & Conditions Policies

1. By purchasing a ticket to attend a Meeple Treks event, you agree to be bound by the following terms & conditions policies. By purchasing a ticket to a Meeple Treks event, you agree that once purchased, tickets may only be refunded or returned at the sole discretion of the Meeple Treks organization. Tickets may not be resold or transferred by anyone, whether at a premium or otherwise, without previous permission in writing from Meeple Treks organization, which shall not be unreasonably withheld.
2. You agree to abide by the rules of the venue. A venue may include, but is not limited to, a private VRBO, private Airbnb, hotel, convention center, or other private/public space. You further agree to comply with all reasonable safety and other announcements or directions from Meeple Treks event organizers and venue employees regarding your attendance at any specific Meeple Trek event. Meeple Treks and any venue employees have the right to refuse entry to or eject from the event any person that is behaving in a manner deemed unsociable; illegal; potentially dangerous; or in breach of these terms and conditions policies, or the Meeple Treks Harassment and Attendance policy. Meeple Treks reserves the sole right to determine and decide which behaviors warrant refusal or ejection. If ejected or refused from a Meeple Trek event for any reason, you are not entitled to a refund. For further information regarding discrimination, harassment, or other proscribed behaviors, please review Meeple Treks' Harassment & Attendance Policy page.
3. Meeple Treks reserves the right to alter or vary any event or to reschedule or cancel all or part of any event, if required by the venue or other outstanding or emergency circumstances.
4. Meeple Treks and any relevant venue reserve the right to search all persons and personal property if necessary for security or other purposes. Meeple Treks does not assume any responsibility for lost or stolen property during any Meeple Trek event. Attendees are expected to maintain and protect their personal property.
5. You give your express consent to the use of your likeness in connection with the production or exhibition of any photograph, film, video, or audio recording of any Meeple Treks event by Meeple Treks for any lawful, promotional purpose.
6. With the exception of service animals, as defined by the Americans with Disabilities Act, no animals will be permitted inside any Meeple Treks event and/or venue.

7. You are eighteen years old or older, or if you are under eighteen years old, you will be accompanied by a parent or guardian. Both you and your parent or guardian must purchase separate tickets. Organizers may request proof of age upon entry.
 8. Attendees at any Meeple Treks event assume reasonable risk of injury. Neither Meeple Treks nor the venue will be held liable for any loss, cost, expense, injury, or damage sustained during a Meeple Treks event except as a result of recklessness by the venue or Meeple Treks, respectively. In the event of any of the above—save recklessness, you agree to hold harmless and indemnify Meeple Treks and the venue, and their respective employees, staff, and organizers.
 9. These terms and conditions shall be governed by the laws of the State of Utah and you agree to the exclusive jurisdiction of the courts of Utah in any dispute arising from your attendance at any Meeple Treks event.
 10. If any provision of these terms and conditions is found to be invalid or unenforceable by any court, the invalid or unenforceable provision shall be severed or amended in such a manner as to render the rest of the provisions and remainder of the agreement valid or enforceable. Further, Meeple Treks leadership have the exclusive right to interpret and enforce these terms, conditions, and policies at its sole discretion.

Meeple Treks Harassment & Attendance Policy

Meeple Treks is committed to creating a safe and enjoyable environment for everyone to play and enjoy playing games and socializing. As such, Meeple Treks will be an environment free from all forms of discrimination and harassment. In short, Meeple Treks expects all participants to treat each other with mutual respect and courtesy. Violators of these attendance policies will be ejected from any Meeple Treks event in accordance with the Meeple Treks terms, conditions, and policies.

If you have observed or been subject to discrimination or harassment, please report the incident to a member of the Meeple Treks leadership team as soon as possible. Meeple Treks leadership will promptly and respectfully investigate each complaint. Meeple Treks leadership will address each individual situation in accordance with these attendance policies and the Meeple Treks general terms, conditions, and policies.

Harassment is behavior that the actor reasonably knows or should have known will annoy, threaten, intimidate, alarm, or put any person in fear of their safety. Harassment and discrimination by any attendee based upon a protected class: race, color, or national origin; gender, sexual orientation, or gender identity; age; political beliefs; physical or mental disability; or any other immutable status will not be tolerated. Proscribed conduct includes the following: use epithets, slurs, and negative stereotyping; the projection or representation of offensive symbols; or threatening, intimidating, or hostile acts that demonstrate aversion toward an individual or group.

If any participant engages in harassing behavior, Meeple Treks leadership may take any action they deem appropriate, including warning the offender or expulsion for any event with no refund. Again, if you are being harassed, notice that someone else is being harassed, or have any other concerns, please contact any member of Meeple Treks leadership team immediately.
